Evaluation Methods Used: Tool was evaluated manually by a programmer. Browsers tested include Google Chrome Chrome Version 113.0.5672.127 (Official Build) (64-bit), Firefox, Microsoft Edge for Business Version 124.0.2478.67 (Official build) (64-bit); Mac – Safari, Chrome, Firefox, and Edge. Screen readers tested include Job Access With Speech (JAWS), NonVisual Desktop Access (NVDA) and Apple VoiceOver. Captions were tested using Vimeo’s captioning tool. North Carolina State University’s Color Contrast Analyzer chrome extension was used to test color.
